## Ex-Afghan intelligence chief announces the formation of new political party

## Bangladesh Bank eases forex regulations for companies in EPZs

Bangladesh Bank (BB) has relaxed foreign exchange regulations for the companies in Export Processing Zones (EPZs) to bring uniformity in regulations between enterprises of EPZs and Economic Zones (EZs). "Equity from foreign shareholders and authorised loan received in foreign currency from external sources may be credited in Foreign Currency (FC) accounts of 'Type A' and 'Type B' enterprises of EPZs," reports BSS citing said a BB circular on Sunday.

## Bangladesh eyeing FTAs with Brazil, Argentina: Commerce Minister Tofail

Commerce Minister Tofail Ahmed has said Bangladesh government has plans to sign free trade agreements or FTAs with two major South American countries - Brazil and Argentina. The FTA with Sri Lanka with the aim to boost bilateral trade will also be signed this year, he reaffirmed when asked by reporters at the Secretariat on Sunday. Dhaka has been negotiating the FTA with Colombo since 2013 to increase trade now worth \$80 million every year. This would be Bangladesh's first deal for free trade with any country.

## Bhutanese Govt. still studying the impacts of GST system

Even as the GST regime in India has already affected many sectors of the Bhutanese economy, the government is

yet to thoroughly understand the system before making any move. Some industrialists and traders have received notifications from Indian counterparts that prices of goods would increase after the application of GST. The Bhutanese side has requested the government of India to issue a clarification on export of goods from India because GST on Indian exports are not only zero rated, but also the excise duty component, which was imposed in the earlier tax regime, will be done away with. Thus, the prices of goods imported from India should drop.

## Manitar-Raidak-Lhamoizinkha highway remains blocked

Except for the block at Manitar-Raidak-Lhamoizinkha road, all the highways blocked recently have been cleared, according to the officials from Department of Roads (DoR). A DoR engineer, Neten Tshering, said that there are three blocks at the Manitar-Raidak-Lhamoizinkha area. "Although two blocks at the area have been cleared, clearing the remaining one will take about a week." He said that the machinery has been deployed in the area and work to clear the block had already begun. The road has been blocked since July 9.

## 3 killed in Rakhine explosion: Myanmar police

Three people, including two teenage boys, were killed by an explosion in Myanmar's restive Rakhine state on Saturday, a police officer said. Police were investigating if the mine had been laid intentionally or if the victims had accidentally struck unexploded ordnance leftover from a previous conflict, an officer told AFP. "According to our initial information, it was a homemade mine," the officer said, requesting anonymity.

## Rs 700m 'stolen' in Rs 1.5b NOC land deal

Nepal Oil Corporation (NOC), the country's petroleum monopoly, has been found to be indulged in financial irregularities worth multi-million rupees while procuring land plots across the country. In various parts of the country, NOC has paid as high as four times the market price to purchase plots of land to build storage facilities.

The apparent corruption was committed in collaboration with multiple land agents. In doing so, the land agents and NOC's high-level officials have illegally pocketed millions of rupees.

## Panama Papers case: SC takes up JIT report, PML-N files objections

As the Supreme Court (SC) resumed the Panamagate hearing on Monday, lawyers of PML-N and Finance Minister Ishaq Dar submitted documents containing objections to the "damning" final report of the joint investigation team (JIT) that probed allegations of money laundering against the Sharif family. A three-member apex bench, headed by Justice Ejaz Afzal Khan and comprising Justice Sheikh Azmat Saeed and Justice Ijazul Hassan, began hearing the case as it returned to the SC after nearly two months. Prior to the hearing, opposition leaders, including Awami Muslim League (AML) chief Sheikh Rashid, arrived at the apex court and spoke to the media, reiterating their demand for Prime Minister Nawaz Sharif's resignation.

#### Attack foiled: Four terrorists killed in Zhob

Four TTP terrorists were killed on Sunday when security forces repelled an attack on check posts near the Pak-Afghan border in the Karez Qamaruddin area of Zhob district.

Security officials said that the terrorists had attacked the Frontier Corps check posts located close to the Pak-Afghan border late Saturday night. They added that the militants had used heavy weapons in the attack. However, the Frontier Corps personnel stationed at the posts returned fire and repulsed the attack. "Heavy exchange of fire took place between security forces and the armed terrorists," the official said, confirming that the four alleged terrorists were killed.

## Army launches Operation Khyber-4 in Rajgal Valley

Director General (DG) Inter-Services Public Relations (ISPR) Maj Gen Asif Ghafoor on Sunday announced the launch of Operation Khyber-4 under Radd-ul-Fasaad (RuF) to "wipe out terrorists" in the Rajgal Valley area of Khyber Agency. "An operation to wipe out terrorists has been launched in Rajgal valley in Khyber Agency," Maj Gen Ghafoor said. Khyber 4 seeks to target terrorist hideouts in what the DG ISPR called "the most critical area in the Federally Administered Tribal Areas (Fata)". There is no timeline for the operation as yet, Ghafoor said in response to a question.

Talks between Sri Lanka and China in pursuit of the coveted Free Trade Agreement (FTA) between the two countries are progressing smoothly and six exhaustive sessions of official talks have been wrapped to-date Minister of Industry and Commerce of Sri Lanka Rishad Bathiudeen says. "Our talks with China are progressing smoothly, the sixth round of talks were successfully concluded in March in Beijing. We are working for the seventh FTA round next," said the Minister addressing the launch of the China Guangxi Products Expo in Colombo.

# Tamil Nadu Chief Minister hits out at Sri Lanka over arrests

The arrest of three state fishermen by Sri Lankan Navy is "disappointing" and shows "high- handedness" by the island nation, Tamil Nadu Chief Minister K Palaniswami said, according to the Press Trust of India. In a letter to Prime Minister Narendra Modi, he said Saturday's arrest and the recent legislation enacted by the Sri Lankan Parliament regarding impounding of boats and imposing huge fines on Indian fishermen cause a sense of "fear and unrest" among the fisherfolk. "When the Government of India as well as Government of Tamil Nadu are making all possible efforts to bring an amicable solution to fishing issues in the Palk Bay, the Sri Lankan Government's response is not only disappointing but also a display of high-handedness," Palaniswami said.
